



KINNEX REIMBURSEMENT CHECKLIST

Kinnex™ Reimbursement

- ✓ Detailed RX
- ✓ Evaluation justifying medical necessity
 - Patient clinical history
 - Document functional level
 - Outcome Measure Tests
- ✓ Doctor's notes that corroborate CP's notes (listed above) that mention need for Microprocessor Ankle
- ✓ PT evaluation and notes
- ✓ Letter of Medical Necessity (LMN)
- ✓ If used: L5999 justification documentation
- ✓ Documented proof of physical change or a change in the patient's condition or other need for replacement
- ✓ Advanced Beneficiary Note (ABN) if appropriate
- ✓ Repair estimate (if replacing a same or similar MPC ankle with same coding)
 - Documentation of why replacement is the only option
- ✓ Cadence Report printout from Kinnex GaitLab App
- ✓ Summary of Evidence (Short version)
- ✓ Verify benefits and coverage with Payer
 - Identify any carve outs, exceptions or exclusions
 - Confirm that the plan does not describe Micro-processor technology as "experimental"

- 1 Kinnex Pilot Study**
Overview: Research Pilot study for 4 individuals comparing Kinnex to Pacifica LP identifying benefits of Kinnex on ramps and hills, balance, mobility and socket comfort
When should this document be used? Submit this document with appeal if claim is denied
- 2 Kinnex Summary of evidence (Short)**
Overview: An abbreviated report summarizing the evidence that established the Kinnex benefits based on function proven by literature on MPC Ankles and Kinnex in six areas
When should this document be used? Submit this document with preauthorization packet
- 3 Kinnex Summary of Evidence (Full)**
Overview: An all-inclusive report that establishes the Kinnex benefits based on function proven by literature on MPC Ankles and Kinnex
When should this document be used? Submit this document during first appeal if claim is denied
- 4 Letter of Medical Necessity**
Overview: Template for letter of medical necessity that explains benefits of Kinnex customized for your patient
When should this document be used? Enter patient information and submit with preauthorization packet
- 5 L5999 justification**
Overview: List of miscellaneous codes that can be added for additional reimbursement if desired
When should this document be used? Use the codes desired based on patient needs to submit with preauthorization packet
- 6 Investigational Denial Rebuttal**
Overview: Response to claim denial based on device being “experimental” or “investigational”
When should this document be used? Submit this document with first appeal if claim is denied
- 7 Outcome Measures**
Overview: Identifies ways for clinicians to use outcome measures to document known benefits of the Kinnex
When should this document be used? Use these tests for documentation for submission with preauthorization claim or with first appeal if additional info is needed
